Bruner, like Vygotsky, emphasized the social nature of learning, citing that other people should help a child develop skills through the process of scaffolding. '[Scaffolding] refers to the steps taken to reduce the degrees of freedom in carrying out some task so that the child can concentrate on the difficult skill she is in the process of acquiring' (Bruner, 1978, p. 19).

Bruner built on Vygotsky's social constructional theory from the 1930's which fell into three general claims; higher mental functioning in the individual emerged out of social processes (culture), secondly, social and psychological processes are fundamentally shaped by cultural tools (language) and lastly, the developmental method Zone of Proximal Development (ZPD).
